
Through these grants and other activities, we are poised to encourage positive lasting change in our community. We also continue to support our nonprofit organizations through training and leadership efforts.

Henry P. Custis, Jr.

Leadership and Philanthropy for the Greater Good

Born and raised on the Eastern Shore, Henry P. Custis, Jr. has been a community leader since beginning his work as a partner with the firm of Custis, Dix, Lewis & Custis, LLP. In addition, he was a founding board member of the Eastern Shore of Virginia Community Foundation. "I feel extremely fortunate to call the Shore my home, so I was honored to join my fellow charter board members to develop and create our own Community Foundation. We knew we were doing something special back in 2004 and it's been particularly gratifying to see our vision come to fruition."

A Legacy of Service and Leadership

Custis has volunteered generously in his community having served as president of the Accomack County Chapters of the American Cancer Society and the American Heart Association, served on the board of directors for Riverside Shore Memorial Hospital and the Eastern Shore YMCA. In the realm of education, Mr. Custis spent time on the board of Broadwater Academy and the Eastern Shore Historical Society. He also served on the board of trustees for St. Timothy's School in Baltimore as well as his undergraduate alma mater, Hampden-Sydney College.

In 2000, Custis became a Fellow of the Virginia Law Foundation, an organization that honors lawyers and judges who demonstrate the highest standards of integrity and character and are deemed to be outstanding in their profession and in their community.

Most recently, he received the Tradition of Excellence Award from the Virginia Bar Association.

There at the Start

As with many of his notable undertakings, Henry was there to answer the call to meet a challenge grant from the Norfolk Foundation (later to be renamed the Hampton Roads Community Foundation). The Norfolk Foundation became acquainted with the needs of area nonprofits through years of Eastern Shore grantmaking and agreed to dedicate \$2 million of capital provided the local community could raise an additional \$4 million. Energized by the challenge, Eastern Shore citizens organized and crafted the terms of an affiliate relationship with The Norfolk Foundation.

Created as an affiliate of the Hampton Roads Community Foundation in 2005, the Eastern Shore of Virginia Community Foundation (ESVCF) was established to provide a flexible way for a variety of donors to build endowments to improve the quality of life in Accomack and Northampton counties.

As conceived, the foundation would make grants from foundation assets on a perpetual basis to nonprofit organizations serving Eastern Shore residents.

A Steady Hand

Henry and the other directors worked tirelessly over several years and were successful and the Eastern Shore of Virginia Community Foundation became a reality. In September 2006 ESVCF was granted 501 (c)(3) status, which significantly improved ESVCF's flexibility to accommodate donors.

In the early years ESVCF served as advisor to The Norfolk Foundation on grant requests received from Eastern Shore applicants. In 2009 ESVCF initiated its own grantmaking program and to date has funded over \$4 million in grants with permanently endowed funds of over \$15 million.

Guided by Gratitude

Looking back over nearly 20 years of history with the ESVCF, Henry reflected, "I know we made a great decision for the Shore back at the beginning of the foundation and all the hard work was worth it. The Shore and the lives of its residents have been positively influenced by the work of the Foundation and I take great pride and comfort in knowing the Foundation is permanently endowed and will continue to do great work in perpetuity. It's gratifying knowing we're inspiring philanthropy and improving the lives of Shore residents every day".



ESVCF Mission

To create and provide philanthropic resources to meet a broad range of needs for the benefit of the Eastern Shore of Virginia by:

Enabling donors to meet their charitable goals through prudently administered, permanently endowed funds.

Offering a comprehensive array of services to encourage, advance and educate donors about effective philanthropy.

Making critical grants to meet current and emerging community needs and opportunities.

What is a community foundation?

It is a nonprofit organization that manages a permanent endowment helping improve life in a specific geographic region. There are more than 750 community foundations in the United States – 30 in Virginia. Ours was founded in 2004 as an affiliate of the Hampton Roads Community Foundation and was built over nearly two decades by generous donors from all walks of life.

What is the Eastern Shore of Virginia Community Foundation?

The Eastern Shore Community Foundation is a 501(c)3 organization dedicated to making life better on the Eastern Shore of Virginia through leadership, philanthropy, and civic engagement. Since 2004, the Foundation has awarded more than \$4 million from its endowment fund in the form of grants to nonprofits. Through research and funding, the Foundation brings the community together to tackle important local concerns and to advance racial equity.

How did the Eastern Shore Community Foundation get started?

In 2004, several local business leaders joined together to create the Foundation as an affiliate of the Hampton Roads Community Foundation. These funds were matched with funds from the HRCF to create a \$4 million foundation for the Shore.





How do your charitable funds work?

We manage nearly 60 charitable funds. Each retains the identity and purpose established by the original donors and follows the donors' intent. For most funds, each year we distribute for grants or scholarships 4.5% of the value of a fund (computed over 12 trailing quarters). The rest is invested to grow for the future.

How are funds invested?

Our endowed funds are invested for long-term growth in partnership with Spider Management Company LLC, our investment manager. Our goal is to provide grants and scholarships now as endowed funds grow over time. The HRCF Board of Directors sets the investment policy and monitors investment performance with oversight from the HRCF Investment Committee.

How does the community foundation help Eastern Shore?

We award grants semi-annually to about 10-15 nonprofit organizations. Beyond funding, we convene working groups, participate in partnerships to tackle issues in our community, and train area nonprofits.

Featured 2022 Grant Recipient

Eastern Shore Community College Foundation

Incorporated in 1997, the Foundation is a 501(c)(3) organization operating with its own Articles of Incorporation and by-laws. It is the supporting arm of the College but is fiscally and organizationally separate from the College. Operations of the Foundation are conducted by the Executive Director with oversight from the Board of Directors. The Board includes the President of Eastern Shore Community College who has ultimate control over all institutional fundraising policies.

The mission of the Eastern Shore Community College Foundation is to make a positive difference in the lives of all Eastern Shore citizens by helping to provide the best possible learning and teaching environment.

Since its inception, the Foundation has raised close to \$5 million through annual fund drives, a major gifts campaign and fund-raising events. These funds have been used to construct a new Workforce Development Center and college access road, purchase furniture and equipment, support the Project Horizons program, and increase its endowment to ensure that future students get the assistance they need to attend ESCC.

In addition, the money the Foundation raises provides ten ESCC Foundation scholarships. The Foundation also serves as the administrator for scholarships that are funded by individuals or organizations. These scholarships are a lifeline for many students; without them, these students would not be able to attend ESCC.

Funds raised by the Foundation are also used for a wide range of specific activities including, but not limited to, stipends for student interns, minigrants for faculty and staff professional development and / or student activities, support of the Center for Student Achievement, computer software and hardware for instruction and support programs, classroom equipment, facilities, new programs, and College marketing efforts.



In 2022, the Eastern Shore of Virginia Community Foundation was pleased to provide \$25,000 to the ESCC Foundation to develop an updated and more functional website.

Riverside Shore Memorial Hospital Auxiliary

The story of the Riverside Shore Memorial Hospital Auxiliary is founded on a love of Virginia's Eastern Shore and those who call it home. Before a single brick was placed for a hospital in this region, the first Auxilians were already hard at work gathering support and funds. That was nearly 100 years ago. Today, the scope may be different, but the passion is the same. Auxiliary members work to improve the care and services available at Riverside Shore Memorial Hospital through fundraising efforts and special Auxiliary events throughout the year.

The vast contributions of the Auxiliary have facilitated improvements in nearly every area of the hospital, from refurbished waiting areas and patient rooms to new surgical and diagnostic equipment. The hospital Gift Shop is also completely staffed by Auxiliary volunteers.

This past year, the ESVCF recognized the long history of hard work and support for better health care in our community by providing a \$50,000 to assist in the purchase of new ophthalmology surgical equipment.

Your legacy of generosity, forever

Call them what you want: bequests, trusts, wills, estates, or charitable giving instruments. All are tools to continue or establish your legacy of caring, forever. And, planned giving enables philanthropic individuals to make larger gifts to charitable organizations than they could generally make from ordinary income.

Some planned gifts provide life-long income to a donor. Other gift plans use estate and tax planning to provide for charity and heirs in ways that maximize the gift and/or minimize its impact on the donor's estate.

Thus, by definition, a planned gift is any major gift, made in lifetime or at death as part of a donor's overall financial and/or estate planning. These include gifts of equity, life insurance, real estate, personal property, or cash.

By contrast, gifts to the annual fund or for membership dues are made from a donor's discretionary income, and while they may be budgeted for, they are not planned.

Whether a donor uses cash, appreciated securities/stock, real estate, artwork, partnership interests, personal property, life insurance, a retirement plan, etc., the benefits of funding a planned gift can make this type of charitable giving very attractive to both donor and charity.

What Are the Three Types of Planned Gifts?

- 1) outright gifts that use appreciated assets as a substitute for cash;
- 2) gifts that return income or other financial benefits to the donor in return for the contribution;
- 3) gifts payable upon the donor's death.

What Gift Plans Pay Income for Life to Donors?

Charitable gift annuities make fixed payments, starting either when the gift is made (an immediate-payment gift annuity) or at a later date (a deferred or flexible gift annuity). Some organizations maintain pooled income funds, which commingle donations, pay beneficiaries variable depending on the earnings of the fund, and generally operate like a charitable mutual fund. Charitable remainder unitrusts and annuity trusts are individually managed trusts that pay the beneficiaries either a fixed percentage of trust income or a fixed dollar amount.

What Might be some of the Tax Benefits of Planned Gifts?

Donors can contribute appreciated property, like securities or real estate, receive a charitable deduction for the full market value of the asset, and pay no capital gains tax on the transfer.

Donors who establish a life-income gift receive a tax deduction for the full, fair market value of the assets contributed, minus the present value of the income interest retained; if they fund their gift with appreciated property they pay no upfront capital gains tax on the transfer.

Gifts payable to charity upon the donor's death, like a bequest or a beneficiary designation in a life insurance policy or retirement account, do not generate a lifetime income tax deduction for the donor, but they are exempt from estate tax.

Types of Funds

DONOR ADVISED FUNDS

Donor advisors can contribute assets at any time and then recommend grants to nonprofit organizations from the advised funds they have established.

FIELD OF INTEREST FUNDS

Donors are able to address an area of concern, such as arts and culture, education, the environment or human services. These funds allow the Foundation's Board to choose specific nonprofit organizations as grant recipients who meet a donor's criteria.

UNRESTRICTED FUNDS

These funds support responsive and strategic grants and broad, evolving community needs. The use of these funds are left to the discretion of the Foundation's Board of Directors, which regularly reviews proposals from area nonprofit organizations.

SCHOLARSHIP FUNDS

These funds provide students with financial resources for college and other educational opportunities. Donors can establish criteria for the scholarship.

DESIGNATED FUNDS

Donors are able to select specific nonprofit organizations to receive support as long as the organizations remain in existence and continue their charitable purposes.

ORGANIZATIONAL FUNDS

These funds are established by nonprofit organizations to generate income for their own use.

ESVCF Funds

The funds listed here, totaling \$14,530,000 as of December 31, 2022, comprise the entirety of the capital assets of ESVCF. Fund assets are managed by the Hampton Roads Community Foundation. The HRCF makes 4.5% of the fund's trailing 12-quarter average balance available to meet each funds' charitable purposes annually.

Types of Charitable Funds Available:

Unrestricted funds tackle an array of critical community needs now and those in the future we can't imagine now.

Field-of-interest funds provide grants to nonprofits working in key areas of concern such as arts, education, or the environment.



Donor-advised funds let living donors recommend grants to specific nonprofits as an alternative to having a private foundation. See below for the five types of donor-advised funds available.

Scholarship funds help college students pay for their education.

Designated funds forever provide annual grants to specific nonprofits that you choose. Organizational funds are for nonprofits wishing to start an endowment.

5 Options for Donor-Advised Funds:

The Eastern Shore of Virginia Community Foundation offers the following options for starting a donor-advised fund – one of the fastest-growing forms of philanthropy:

Endowed – Your legacy will last forever through this endowed, permanent fund that lets you and successor advisors recommend grants to nonprofits. When the advising period ends, your fund will become the type of charitable fund of your choice, such as unrestricted, scholarship, or field of interest. (Initial charitable gift: \$25,000 or more.)

Current-use – You make one donation and then recommend grants to nonprofits until you spend the fund balance. (Initial charitable gift: \$50,000 or more.)

Quasi-endowed – You and your successor advisors can recommend unlimited grants to nonprofits as long as your fund keeps a minimum balance of at least \$50,000. When the advising period ends, your fund becomes a permanent charitable fund with the purpose you specified. (Initial charitable gift: \$50,000 or more.)

Customized – You create a specialized donor advised fund that meets your needs now and helps others through your generosity. (Initial charitable gift: \$2 million or more.)

Corporate – Businesses or corporations may create a donor-advised fund and recommend grants to nonprofits. (Initial charitable gift: \$25,000 or more.)

The affiliate relationship between the Eastern Shore of Virginia Community Foundation and the Hampton Roads Community Foundation (HRCF) places stewardship of ESVCF capital assets with the Hampton Roads Community Foundation. Through its investment committee, which has investment oversight responsibility for an endowment of approximately \$532 million, the Hampton Roads Community Foundation seeks to invest resources prudently in order to preserve and grow the endowment's capacity to fund grants in accordance with donors' wishes today and in the future.

The Hampton Roads Community Foundation is committed to being a good steward of the assets entrusted to it by generous donors over the past 68 years. HRCF invests its resources wisely so they grow to meet future needs while providing funds for grants and scholarships today. Oversight of HRCF investment portfolio is handled by its investment committee, which works with its investment manager, Spider Management Company LLC of Richmond. Since 2011 the community foundation began investing with Spider Management through its Richmond Fund. The Hampton Roads Community Foundation joins University of Richmond and other nonprofit endowments as Spider Management partners.

Spider manages approximately \$4.1 billion in assets and provides us access to a mature, well-diversified investment portfolio managed by a professional staff with an excellent performance record. It also gives a snapshot of the portfolio's asset allocation as of December 31, 2021.
